She has assisted with the defense of a company and its principals, who were alleged to have committed criminal export violations but later received a formal declination letter from the Department of Justice's National Security Division.

Zeynep has supported litigation matters involving some of the world's largest tech companies in antitrust cases. She was part of the core trial team representing Epic Games that secured a jury verdict against Google. She has also supported the criminal defense of crypto currency companies and individuals alleged to have violated SEC regulations and federal criminal laws.

Prior to joining Wiggin and Dana, Zeynep interned at Raytheon Technologies Corporate Headquarters (f/k/a United Technologies), where she focused on data privacy and security compliance. She earned her Juris Doctorate from University of Connecticut School of Law, where Zeynep was the Lead Articles Editor of the *Connecticut Journal of International Law*.
